

## EULA (End User License Agreement)

### **Your Consent Statement to The Following Agreement**

It is suggested to go through all the terms and conditions of the software before you install, use and market the software. You can escape the terms and conditions in case you have a separate agreement signed with the Recovee software.

In case you do not agree with any of the terms and conditions linked to the license of this software, it is advised that you do not install, download, use, and copy the license of the software.

The terms and conditions linked with each license of the software determine that how to use software and how it is restricted to only approved users. After you have bought a single copy of the license of Recovee OST to PST software, only single use of the license is permitted. In contrast, when you buy several copies of the license, then you and your company are allowed to use the number of copies that is evidently cited in the agreement of the license by Recovee software.

### **The Scope of The License**

The software license has been created in such a manner that it need not be used in an intensive manner. In case of a single copy of the license, you as the single user are only allowed to use the software copy in accordance with the agreement. Nonetheless several users are allowed to use OST to PST converter software with many copies of license, you have to make sure that the software is used one at a time and not in a simultaneous manner.
